A person who is obligated to pay taxes under a contract to purchase taxable property within the District(s) shall be considered an owner of taxable property for the purpose of qualifying as an eligible elector.

**NOTICE IS FURTHER GIVEN** that applications for absentee voter ballots may be filed with the Designated Election Official at the address set forth above no later than the close of business on the Tuesday immediately preceding the elections. Return of absentee voter ballots and replacement ballots may be received by the Designated Election Official at the above address, Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m. beginning on April 14, 2025, until the day prior to the elections, or between the hours of 7:00 a.m. and 7:00 p.m. on the date of the elections.
